**Effective April 1, 2019**, Medina County Residents may bring yard waste to the center up to thirteen (13) times during the calendar year, for free, by completing and returning a 2019 Residential Yard Waste Permit Voucher Application. You will receive your personalized, numbered, Yard Waste Permit Vouchers via United States Postal Service or in person by scheduling an appointment with Ann Foky at 330-769-0289. Quantities per visit are limited, and additional visits or excess quantities will be charged at the appropriate fee of \$21.00 per ton. No yard waste will be accepted without a personalized, numbered Yard Waste Permit Voucher or the applicable cash / check payment.

# Medina County Solid Waste District

## 2019 Residential Yard Waste Permit Voucher

This permit is issued for residential yard waste to be accepted at the Medina County Recycling Center, 8700 Lake Road, Seville, Ohio 44273. Bearer of this permit may bring yard waste to the center up to thirteen (13) times during the calendar year for free. Quantities per visit are limited as follows:

- Up to six (6) 50-gallon bags;
- Up to one (1) standard pick-up truck filled no more than two feet high;
- Up to one (1) six foot trailer filled no higher than two feet high.

Additional visits or excess quantities are allowed with payment of the appropriate fee of \$21.00 per ton. Each visit shall require the submission of one of your personalized, numbered, Yard Waste Permit Vouchers. Under NO circumstances will yard waste be accepted without a Yard Waste Permit Voucher or the applicable cash/check payment.

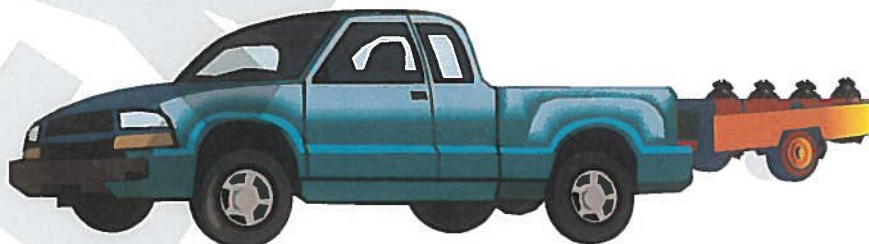
Up to two 50-gallon trash bags
